The Commodore Advantage® variable annuity contract is issued by Annuity Investors Life Insurance Company® (AILIC). The Commodore Advantage offers both variable and fixed investment options. The variable investment options are subaccounts of Annuity Investors® Variable Account B (Subaccounts). Each Subaccount is invested in shares of a registered investment company or a portfolio of a registered investment company (Portfolios).

Table 1 contains information about the performance of the Subaccounts. It shows how the Subaccounts have performed over time and allows a participant or beneficiary to compare them with an appropriate benchmark for the same time periods. Benchmarks do not reflect deductions for fees or expenses of the Subaccounts or Portfolios.
