General Note

Notes for Equity Subaccounts

The Dreyfus Sustainable U.S. Equity Portfolio, Inc. The fund changed its investment objective and strategy on May 1, 2017. Prior to May 1, 2017, its investment objective was to provide capital growth, with current income as a secondary goal. To pursue these goals, until May 1, 2017, the fund, under normal circumstances, invested in the common stocks of companies that, in the opinion of the fund's management, met traditional investment standards and conducted their business in a manner that contributed to the enhancement of the quality of life in America. To determine whether a company contributed to the enhancement of the quality of life in America, the fund considered the company's record in the areas of (1) protection and improvement of the environment and the proper use of natural resources, (2) occupational health and safety, (3) consumer protection and product purity, and (4) equal employment opportunity. In addition, prior to May 1, 2017, investment decisions for the fund were made by members of the Active Equity Team of Mellon Capital Management Corporation, an affiliate of Dreyfus, who managed the fund as employees of Dreyfus.

Franklin Templeton Variable Insurance Products Trust—Templeton Foreign VIP Fund. The MSCI All Country World ex-US Index is replacing the MSCI EAFE Index as the Fund's benchmark.

Invesco Variable Insurance Funds—Invesco V.I. Mid Cap Growth Fund Series I. Series I shares' performance prior to June 1, 2010 is that of the predecessor fund's Class II shares at net asset value and reflects the expenses applicable to the predecessor fund.

The Commodore Independence® variable annuity contract is issued by Annuity Investors Life Insurance Company® (AILIC). The Commodore Independence does not offer fixed investment options. Therefore Table 2—Fixed Return Investments has not been included in this document.

Part II. Fee and Expense Information: Table 3

Table 3 shows fee and expense information related to The Commodore Independence.

Table 3 shows the total annual operating expenses for the Subaccounts listed in Table 1. The total annual operating expenses of a Subaccount are expenses that reduce its rate of return. Total annual operating expenses of each Subaccount include: (1) the total annual operating expenses of the underlying Portfolio; (2) a mortality and expense risk charge of 1.25%; and (3) an administration charge of 0.15%.

Information about shareholder-type fees related to The Commodore Independence is set out below Table 3. These fees are in addition to the total annual operating expenses of the Subaccounts. The Subaccounts and the Portfolios do not charge any shareholder-type fees.

A summary of restrictions and limitations that apply to purchase payments, allocations, transfers, withdrawals, and active trading is also set out below Table 3.

The cumulative effect of fees and expenses can substantially reduce the growth of retirement savings.
