Each transaction will have one associated document. If multiple documents are produced for a given policy transaction, two transactions (one for each document) will be sent. Documents are typically sent 1-2 days after they have been processed. The documents applicable to a given policy depend on the line of business and division in which the policy was written. Only insured copies of our policies are sent via download. Billing documents may not be available for all divisions, and we send copies for each additional insured. Most of documents available in our Agent Portal are available for download.

By default, both Policy and Billing Documents will be sent. However, download can be limited by electing to only receive Policy Documents or Billing Documents.
