**2026 Environmental Division GREAT AMERICAN REWARDS Program**  
**OFFICIAL RULES**

The following rules apply to agents seeking to enter the 2026 Environmental Division GREAT AMERICAN REWARDS Program (the "Program")

**ELIGIBILITY:** Program is open to duly appointed agents of Great American Insurance Company ("Company") and its subsidiaries, who produce business for Great American Insurance Group's Environmental Division.

**DURATION:** Program runs from January 1, 2026 through December 31, 2026.

**DETERMINATION OF PROGRAM REWARDS:** For every policy bound between January 1, 2026 and December 31, 2026, the Company will send an Amazon e-gift card to the email of the user ID that entered the submission or the individual they and the policy underwriter designate as the recipient.

**REWARDS:**

Policy bound in any amount (no minimum dollar amount of the policy) = \$ Amazon e-gift card based on tiers below. The premiums start at \$0 at the beginning of each quarter, no rollover premium would be carried forward. There is no limitation on how many quarters the producer can be awarded a gift card.

QUARTERLY PREMIUM BOUND	GIFT CARD AMOUNT
\$20,000 – \$50,000	\$25
\$50,000 – \$100,000	\$50
\$100,001 – \$250,000	\$100
\$250,000+	\$150

For any producer that binds new or renewal business within the calendar year but does not meet the quarterly premium totals for a gift card, an award will be issued at the end of the calendar year based on the total premium bound using the following criteria:

YEARLY PREMIUM BOUND	GIFT CARD AMOUNT
\$1 - \$50,000	\$25
\$50,001 - \$100,000	\$50
\$100,001 - \$200,000	\$100

**Note: If a producer receives an e-gift card in ANY quarter, he/she is ineligible to receive an e-gift card for Yearly Premium Bound.**

**REWARDS AND CONSUMER DISCLOSURE:** One e-gift card per policy. The e-gift card will be sent to the email of the user ID that enters the submission or the individual they and the policy's underwriter designate as the recipient. Referrals, incomplete applications, and unbound quotes are ineligible. By accepting reward, recipient agrees to release Company and its officers, directors, employees and agents from any and all liability, loss or damage of any kind arising out of or in connection with recipient's participation in the Program, or with respect to the awarding, receipt, possession, use and/ or misuse of the reward, or the participation in reward-related activities. By accepting reward, recipient further agrees that Company is not responsible or liable for any warranty, representation or guarantee, express or implied in fact or in law, relating to the reward, or any portion thereof, including but not limited to its quality, merchantability, mechanical condition or fitness for a particular purpose.
