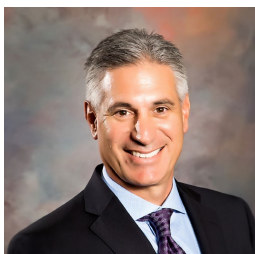

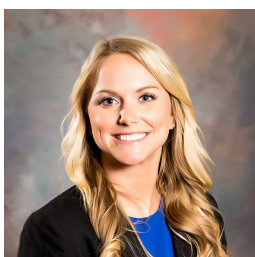
Heather Filliben
