

# Important Changes to Great American's Direct Bill Commission Statements

Effective **March 1, 2019**, we are launching a new "Direct Bill **Monthly** Commission Statement" to provide you with a simpler, more user-friendly view.

## What you need to know:

1. Some columns have been removed/combined to provide a cleaner summary of your earned direct bill commission.
2. Premiums and payments are now summarized by policy at a transaction level (i.e., New Business, Endorsement, etc.) and grouped by commission rate and policy. *The statement continues to be sorted by producer code.*
3. For your convenience, the previous version of the statement, "Direct Bill Commission Statement", will still be available online in MyBilling for the next six months.
4. Starting with February 2019 Commission statements, there will be PDF and CSV files of each version of the commission statement until the old statement is retired. Note: the new statement will contain the word "Monthly" in its title.
