- We offer 2 coverage options, so you can ensure the best fit for your business:
 - Bailee Legal Liability Coverage applies to your business to business operation, covering your responsibility for loss to your customer's property.
 - Bailees' Customers Coverage covers your retail operations for loss to property of your retail clients.
- Misidentification coverage for goods that have not been destroyed, but the goods' owners cannot be identified following a covered loss, due to destruction of records and markings, etc.
- Preservation coverage will cover property moved to avoid imminent loss, while in transit to/from and at a new location for up to 30 days.
- Pollutant clean up and removal coverage with a \$10,000 limit.
- Debris removal at 25% of the amount paid for direct loss plus up to \$25,000 additional coverage if the limits are exhausted.

Optional coverages

- Goodwill Replacement Endorsement to replace your customer's property, which is less than five years old, with substantially identical property.
- Optional coverage for Flood and Earthquake is available when first party Bailees' Customers Coverage is provided.
- Your customers' property can be covered at third party locations, in transit, as well as your locations used for storage or for other purposes.
