or appealing claims made in court or arbitration.

Quasi-Judicial Costs: Automatic extension of coverage for fees and expenses of

investigating, defending, settling or appealing complaints to professional associations, and also for attending or providing

documents to formal inquiries.

Joint Ventures: Automatic extension of coverage for joint ventures of which the

policyholder or a subsidiary takes part.

Document Loss: Automatic extension of coverage for costs of replacing or restoring

lost, destroyed, damaged or erased documents belonging to third

parties under an insured's control or custody.

Fraud or Dishonesty: Optional coverage for civil liability and for the insured's own

financial loss caused by fraudulent or dishonest employees.

Reputation Protection: Optional coverage of fees and expenses for engaging public relations

firms to protect the insured's reputation against negative publicity.
