Agency Incentive Trip Program to Perth 2018 (“AITP2018”)  
OFFICIAL RULES**

- 1. BINDING AGREEMENT:** By participating in the AITP2018, each Eligible Agency agrees to be bound by these rules including its amendments thereof and any decision made by the Company in relation to the AITP2018.
- 2. ELIGIBILITY:** All contracted agencies of the Company are eligible to participate in the AITP2018 (“Eligible Agencies”).
- 3. QUALIFICATION PERIOD:** The AITP2018 qualification period started retroactively from 1 January 2018 and ends 24 December 2018 (“Qualification Period”).
- 4. DETERMINATION OF WINNERS:** An Incentive Trip will be awarded to the top eight (8) most profitable Agencies with GWP of at least S\$350,000 received by the Company (excluding premiums returned due to cancellations and/or refunds) during the Qualification Period providing he/she completes and returns a Liability/Publicity Release form in accordance with rule 5.2 below (“Winning Eligible Agency”).
- 5. TERMS OF THE INCENTIVE TRIP**
  - 5.1 Incentive Trip Inclusions:** Six (6) days, five (5) nights stay in Perth, for one (1) person, and comprising of:
    - (a) One (1) room
    - (b) Economy class airfare tickets
    - (c) Transfer service to and from the airport and the hotel
    - (d) All meals (breakfast, lunch and dinner)
  - 5.2 Liability/Publicity Release:**
    - (a) Each Winning Eligible Agency will be notified by the Company by email or phone (“Notification”). Each Winning Eligible Agency will be required to complete and return a Liability/Publicity Release within ten (10) days of the date of Notification. If a Winning Eligible Agency does not return the Liability/Publicity Release within the indicated time period, that Winning Eligible Agency shall be deemed to have forfeited his/her Incentive Trip which will then be awarded to the next highest Eligible Agency based on the same criteria as set out in Rule 4.
    - (b) Acceptance of the Incentive Trip constitutes permission to the Company to use the name and photographs of each Winning Eligible Agency for publicity purposes without additional compensation.
- 6. OTHER TERMS**
  - 6.1** The Company reserves the right to substitute any part of the Incentive Trip or cancel/ substitute the Incentive Trip with a comparable trip for the same of later travel dates at its sole discretion. The Company reserves the right to postpone the Incentive Trip and/ or change the travel destination of the Incentive Trip due to any unexpected or prevailing circumstances (e.g. war or natural disaster). The Incentive Trip is subject to availability and the Company also reserves the right to extend, shorten or terminate the Incentive Trip without any prior notice and without assigning any reason thereof. The Company’s decision is final and no complaint shall be entertained.
  - 6.2** The Incentive Trip cannot be converted into cash of any kind and cannot be transferred or assigned to any other Eligible Agency or person without the Company’s permission.
  - 6.3** Each Winning Eligible Agency is responsible to ensure that his/her passport has a minimum validity period. Each Winning Eligible Agency is also responsible for the fees relating to any travel documents and all taxes and any expenses associated with the acceptance and utilization of the Incentive Trip other than the amounts specified in Rule 5.1 above.
  - 6.4** Each Eligible Agency agrees to release the Company and its officers, directors, employees and agents from any and all liability, loss or damage of any kind arising out of or in connection with the participation in the AITP2018, or with respect to the awarding, receipt, possession, use and/or misuse of the Incentive Trip, or the participation in any activities related to the AITP2018 and/or Incentive Trip. The Eligible Agency further agrees that the Company is not responsible or liable for any warranty, representation or guarantee, express or implied in fact or in law, relating to the AITP2018 and/or Incentive Trip, or any portion thereof.
  - 6.5** The Company reserves the right to interpret these rules and, if necessary, to amend the rules at its sole discretion and without notice to the Eligible Agency. The Company reserves the right to postpone or cancel the AITP2018 at any time. All decisions by the Company are final.
- 7. DATA PROTECTION**
  - 7.1** The Company will always process personal data with utmost care and in accordance with the Personal Data Protection Act 2012. In agreeing to participate in the AITP2018 and/ or Incentive Trip, each Eligible Agency gives consent to the Company, its affiliates and/ or any third party acting on its or their behalf, both during the course of the AITP2018 and/ or Incentive Trip and for a reasonable period of time thereafter, to collect, use or disclose or transfer to other parties (including third parties who provide products or services to the Company, regulatory authorities, governmental or quasi-governmental organisations) whether in or outside Singapore, or otherwise process such personal data, in connection with management of the AITP2018, Incentive Trip and/ or management of the Company’s business and operations more generally.
  - 7.2** Where an Eligible Agency discloses or will disclose the personal data of third party individuals to the Company, its affiliates and/ or any third party acting on its behalf, each Eligible Agency warrants that he/she has obtained consent from such third party individuals for the Company, its affiliates and/ or any third party acting on its behalf or their behalf, to collect, use or disclose or transfer to other parties the personal data of such third party individuals, for the AITP2018, Incentive Trip and/ or other relevant purposes.
