#### **Summary:**

SafetyFirst has been providing fleet and safety managers safe driver training and coaching strategies since 1999. Our collaboration has had a positive impact on the *Driver Monitoring* industry by reducing motor vehicle accidents and saving lives. With creative input and support from our clients, SafetyFirst has developed an LMS that empowers managers to assign online training modules to drivers <u>based on their risk taking behaviors</u> such as: weaving in traffic, excessive speeding, running stop signs, etc. These behaviors are reported through our Motorist Observation Reports (MORs), SafetyFirst TeleMatic Alerts (TMAs), as well as Motor Vehicle Records (MVRs) from enforcement violations.
